### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £ 7,600 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

## Auditor General's report

### Audit opinion - Qualified

Except for the matters reported in my Basis for Qualification below, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of qualification

#### Annual Governance Statement

In my opinion, the Council's governance statement is not consistent with the actual arrangements in place during the year.

- Assertion 3: Section 40 of the Well-being of Future Generations Act 2015 requires the Council to publish each year, a report of the progress it has made in its area in meeting the local objectives included in the local well-being plan. The Council has not published such a report.

### Other matters arising and recommendations

We note that the Council has not published its wellbeing report as a consequence due to the impact of COVID19. We recommend that the Council prepares its report for 2021-22 as soon as possible.

There are no further matters I wish to draw to the Council's attention.
