40.1 Councillor Mrs J Jones reported the potholes on Chapel Street, Acrefair still have not been filled.

40.2 Councillor Mrs P Roberts reported the footpaths leading from Rhosymedre to Newbridge are needing attention, removal of weeds. – The clerk will report to WCBC 40.3 Councillor Mrs S Benbow Jones wished to record her personal thanks to the caretaker for his help with a recent project she had been doing at the doctors' steps, the caretaker had helped with the clearing of vegetation.

40.4 Councillor Mrs S Mills wished to convey her thanks to all councillors who helped on the recent 'Dog Show' event at Ty Mawr, stating it was a huge success. £249 was raised on the day which will go towards caring for the animals.

40.5 Councillor Mrs S Matthews reported on a recent incident on private land where unfortunately it was reported there was a dead foal. It was reported that highways department are the only department who deal with animal carcasses who cannot enter private land. 40.6 Councillor Mrs S Matthews reported she had verbally spoken to the chief environment officer at WCBC regarding the lack of communication regarding the Newbridge Road repair. It was stated there is a confidential report to be released imminently and if any information can be made public this will be passed to the Clerk. Local members have all expressed their disappointment in the lack of communication. Councillor Matthews stated she had received confirmation the finish date of next Spring has not been altered. Councillor Mrs S Mills reported she had received many complaints as the circular walk is not possible to complete due to the closure, posters and notices have been placed advising walkers 40.7 Councillor Mrs S Matthews reported she had spoken and represented the council at a recent planning meeting regarding the car park for the WHS, she was unable to get a condition regarding the footpaths into the village as this is on an adjoining piece of land not on the car park land but was assured by the chief planning officer that the pathways will be contained. Also, it was reported an application has been submitted for the steps at the Aquaduct. Cllr D Wright reported that planning officers had been reminded that an agreement was made with Eastmans several years ago that a path would be re-instated on 'Oilworks Road' for access from the bottom of Cefn to the village centre, which has been suspended because of the Masterplan. Cllr Wright expressed his extreme dissatisfaction that no funding from either the 'Levelling up' or 'Prosperity Fund' has been utilised in Cefn Community 40.8 Councillor D Wright gave a detailed report regarding the recent Summer Olympics event. The Cross-Country event which was the most feared worked out excellently. The sports day was also a great success, the Tug of War being the ultimate challenge! Councillor D Wright would be eager to hold the event on a yearly basis and as all the equipment has been bought and now in storage, future costs would be minimal. Notes have been prepared if the event is to be on an annual basis of what worked well and what needs slight adjustments. Councillor Mrs G Wright gave a brief report regarding the sportsmanship showed from a pupil from Ysgol Min Y Ddol who selflessly gave up his prime position at the cross-country event to assist a fellow pupil who had fallen over, all members were touched by the kindness shown from the pupil. A special certificate was presented to the pupil from Cefn Community Council. A discussion followed regarding the event, and it was agreed to defer any decision

to be discussed in more detail at the next development committee meeting, all members were in agreement.
