102. TO DISCUSS TRAFFIC CONTROL AT NEWBRIDGE ROAD

Councillor Derek Wright highlighted an issue with approximately 200 meters of cars regularly parked on weekends and evenings near the pub, once rounding the corner. He expressed concerns about potential congestion, particularly when buses attempt to pass, and requested the installation of traffic lights following a site visit with officers and the lead member of Wrexham Council, once the road reopens.

Councillor Sonia Benbow-Jones acknowledged the concerns raised by Councillor Wright and inquired about the possibility of creating parking spaces for residents in the area where Quarry Terrace used to be. Councillor Wright clarified that this was unlikely due to funding constraints within Wrexham Council and reiterated that a traffic light system would be the most effective solution.

Councillor Wright proposed that the council formally write to the Highways Department, urging them to consider implementing a traffic control system within the next 6-9 months. This proposal was unanimously agreed upon by the full council.

108.TO RECEIVE PLANNING APPLICATIONS

P/2024/1618 Erection of 5 light industrial units – class B1 and B8

The cooperative, Well Street, Cefn Mawr

In relation to application P/2024/1618 the clerk was requested to write and make objections in relation to the anticipated increase in traffic to the area, the proposed development is likely to cause significant congestion, particularly regarding parking availability, which would negatively impact residents accessing essential services such as the doctor's surgery. Furthermore, the proposal does not align with our heritage status or the objectives of our tourism initiative, as this location serves as the gateway into Cefn Mawr. We believe the development fails to add meaningful value to the area and could detract from its cultural and historical significance.

P/2024/1629 Erection of 2 dwellings

Land at Tan Y Graig, Off High Street, Cefn Mawr

In relation to application P/2024/1629 no observations/objections were received.

109.REPORTS FROM MEMBERS

109.1 Councillor Derek Wright, reported with his ongoing collaboration with Councillor Stella Matthews (via emails), reported on efforts to address ongoing issues with buses navigating through their wards. Councillor Wright highlighted a recent incident on Queen Street where two buses collided, resulting in the demolition of a wall. He expressed a desire to engage with North Wales Police to clarify the legal position regarding buses causing damage to residents' properties, as affected residents perceive this as criminal damage.

Councillor Wright further noted that over the past 12 years, all properties along the boundary wall have experienced damage due to similar incidents. He also reported that Arriva has consistently refuse to accept liability, stating that the buses are too wide to use alternative routes. The issue remains unresolved and under continued discussions.

Councillor Wright reported observing men working at the old Flexys site, specifically conducting soil sampling at the main site and the SE Jones lorry section. This activity was confirmed by Mike Bathers of Wrexham Council. However, Mike Bathers has informed Councillor Wright that he is leaving his position with the Council, and all future correspondence regarding ongoing works, including those related to the cemetery extension, should be directed to another colleague.

Councillor Wright informed the council that the SOS site at the old Saunders Garage has now been cleared following his persistent efforts, including requesting Wrexham Council to employ a road sweeper. This resolution came after he reported the issue on ten separate occasions.

Councillor Wright informed the council that he had received an email from Carl Hughes of HDS Architects in Wrexham regarding a 20-day pre-consultation period for a proposed

development of 21 one-bedroom flats at the old Wheatsheaf site in Rhosymedre. While Councillor Wright acknowledged that this development falls within Councillor Stella Matthews' ward, he was unsure whether she had received the email.

Councillor Wright requested a site meeting on January 6, 2025, with Councillor Karen Benfield, Clerk Trina Nicholl-Smith, and Councillor Chair Phil Vaughan. His primary concern is that the development could lead to an additional 42 cars, exacerbating traffic congestion in the area. He also emphasized the importance of preserving the cornerstone of the Wheatsheaf site to be included in the Cefn Mawr Museum should the buildings be demolished.

109. 2 Councillor Chair Phil Vaughan reported in response to a question from Councillor Sonia Benbow-Jones regarding the trees at Trefynant Cemetery. He stated that he was waiting for the trees to be marked and is currently in discussions with several potential companies to decide on the best contractor for the work.

Councillor Phil Vaughan further raised the issue of ongoing fly-tipping behind the George Edwards Hall, and asked Cllr D Metcalfe to address the situation. In response, Councillor Metcalfe explained that there are ongoing plans for the area, which include the construction of a bank with a retaining wall, and that drawing plans for this are in place. Councillor Isabel Twigg suggested that Mr. Chairman Phil Vaughan and Councillor David Metcalfe meet to review the plans before providing any further updates to the council.

109.3 Councillor Sonia Benbow-Jones reported receiving urgent communications from residents regarding recent flooding on Bowers Road and behind the Delph. She noted that the farmers' fields are deteriorating, and it is believed that blocked culverts may be contributing to the flash floods. In response, Councillor Paul Blackwell clarified that the council cannot enforce farmers to clear the culverts and suggested that entering into positive negotiations is the only viable solution.

Councillor Derek Wright advised that the council should write to Councillor Stella Matthews, Wrexham Council's Kenny Williams, and Kevin Edwards to address the blocked drains causing flooding, and perhaps initiate discussions with the farmer regarding the flooded fields.

109.4 Councillor Joan Jones reported that a fence at Trefynant Cemetery has collapsed and requires repair. She also commented that the Christmas lights in Cefn were lovely.

The Chairman thanked members for their attendance, and declared the meeting closed.
